MINUTES

1. Opening

- a. Call to Order & Roll Call

Chair Janice Moore called the meeting to order at 5:05 p.m. Present were Councilman Browning, Councilman Tom Goltzené and Councilman Jim Rockett. Also present were Town Manager Mark Kutney and Town Attorney Michael D. Cirullo, Jr.

2. Canvass the Official Results of the March 13, 2012 Municipal Election As Provided By PBC Supervisor of Elections

- a. Approval of Certification

Chair Moore explained that under the provisions of the Charter, Article 7, the Canvassing Board was composed of the Clerk, who acts as Chair, and the Council Members who were not candidates for re-election. She further explained that the Canvassing Board met to certify the vote. Chair Moore reported that the Town had received the official certification of the results of the election on March 15, 2012 from the Palm Beach County (PBC) Supervisor of Elections with the total votes cast for Seat 3 being 455:

- Byrnes Guillaume received 183 votes (16 absentees)
- Ryan Liang received 272 votes (21 absentees)

Motion: Councilman David Browning moved to **declare** Ryan Liang as the winner of the election for Seat #3 and that the Canvassing Board incorporate the results of the election, as certified by Susan Bucher, PBC Supervisor of Elections, as their own certification. Councilman Tom Goltzené seconded the motion, which passed unanimously. **(Motion carried 4-0).**

A copy of the certified results was attached to these minutes.

Manual Audit of Voting System

Chair Moore reported that the PBC Supervisor of Elections conducted a manual audit of the voting system that morning at the Tabulation Center in Riviera Beach. She noted that the purpose of the manual audit was to ensure that the voting system deployed in the election tabulated all votes properly. She further reported that all went well, and a copy of the report would be forwarded when received.

3. Adjournment

Motion: Councilman Rockett moved to **adjourn** the meeting at 5:15 p.m. Councilman Browning seconded the motion, which passed unanimously. **(Motion carried 4-0).**


