Logic & Accuracy Testing: February 22, 2013, @ 3:00 pm.

1. Call to Order and Roll Call

2. Review Legal Advertisement for Notice of Public Meeting

The Palm Beach County Supervisor of Elections, Susan Bucher, reviewed the legal advertising requirement.

3. Commence L & A Test of Voting Equipment

The voting equipment to be used by the Town of Loxahatchee Groves was tested and the equipment passed the test.

4. Other Business

The schedule of Canvassing Board meetings was reviewed.

5. Adjournment

The Logic & Accuracy Test was adjourned at 3:25 p.m.

Election Day: March 12, 2013 @ 7:00 pm.

Canvassing Board Members Present were: Councilmen Tom Goltzené, Ron Jarriel, and Town Clerk Susan Eichhorn. Town Attorney Michael D. Cirullo, Jr, and Town Manager Mark Kutney were also present.

After the procedure was conducted in which the ballots were accounted for, the Palm Beach County Supervisor of Elections distributed the unofficial results of the Town of Loxahatchee Groves Municipal Election, which was: 594 total ballots cast; 312 for Jim Rockett, and 282 for Todd McLendon. One provisional ballot was received and documented, however, there was not a signature on the ballot; therefore, it was not counted. The unofficial results were presented to Town Clerk Eichhorn, and the Town of Loxahatchee Groves was dismissed from the Palm Beach County Supervisor of Elections warehouse at 10:10 p.m.

Post Election Audit: March 18, 2013 @ 9:30 a.m.

Since the Town of Loxahatchee Groves had only one precinct, Precinct 6094 was audited.

5. Audit Team to Begin Audit Process

The Palm Beach County Supervisor of Elections Audit Team counted and audited all ballots and all absentee ballots. The results were 274 ballots for Todd McLendon cast on Election Day, and 8 absentee ballots cast; 285 ballots for Jim Rockett cast on Election Day, and 27 absentee ballots cast.
