MINUTES

1. OPENING

a. Call to Order & Roll Call

The Canvassing Board Meeting was called to order by Chair Susan Eichhorn at 5:12 p.m. Present were Councilmen Tom Goltzené, Ronald D. Jarriel, and Ryan Liang. Also present were Town Manager Mark Kutney and Town Attorney Michael D. Cirullo, Jr.

b. Approval of Canvassing Board Meeting Minutes from:

L & A Testing: February 22, 2013, @ 3:30 pm.
Election Day: March 12, 2013 @ 7:00 pm.
Post Election Audit: March 18, 2013 @ 9:30 a.m.

(Please Note: There was no need for the scheduled Canvassing Board Meeting of March 11, 2013 @ 9:30 a.m., since our municipality did not have any absentee ballots to canvass)

Motion was made by Councilman Liang, seconded by Councilman Jarriel to approve the Canvassing Board Meeting Minutes from the Canvassing Board Meetings at the Palm Beach County Supervisor of Elections offices, held on February 22, 2013, March 1, 2013, and March 18, 2013. The motion carried unanimously.

2. CANVASS THE FINAL RESULTS OF THE MARCH 12, 2013, MUNICIPAL ELECTION AS PROVIDED BY THE PALM BEACH COUNTY SUPERVISOR OF ELECTIONS.

a. Approval and Certification of Final Results

Chair Eichhorn explained that under the provisions of the Charter, Section 7(5), the Canvassing Board was composed of the Town Clerk, who acts as Chair, and the Council Members who were not candidates for re-election. She explained that the Canvassing Board met to certify the results of the election. Chair Eichhorn reported that Candidate Dave Browning, Seat 4, had been without opposition in the election, and had therefore been deemed elected. The Town had received the final results of the election on March 18, 2013 from the Palm Beach County Supervisor of Elections with the total votes case for Seat 2 being 594:

- Todd McLendon received 282 votes total (total including 8 absentees)
- Jim Rockett received 312 votes total (total including 27 absentees)

Motion:

- 1. Councilman Ryan Liang moved to declare and confirm the election of Dave Browning without opposition, in accordance with the Town of Loxahatchee Groves Town Charter Section 7(7)(b), and in accordance with the Town of Loxahatchee Groves Ordinance No. 2012-13, Section 2(1).**
- 2. Councilman Ryan Liang moved to certify the results of the election held on March 12, 2013, to confirm that Seat 2 Candidate Jim Rockett prevailed with a total of 312 votes, which includes 27 absentee ballots; and to certify and confirm that Seat 2**

Opponent Todd McLendon received a total of 282 votes, which includes 8 absentee ballots.

The motion was seconded by Councilman Ronald Jarriel, and carried unanimously.

Manual Audit of Voting System

Chair Eichhorn reported that the Palm Beach County Supervisor of Elections conducted a manual audit of the voting system this morning at the Tabulation Center in Riviera Beach. She noted that the purpose of the manual audit was to ensure that the voting system deployed in the election tabulated all votes properly. The overall accuracy of the audit was one-hundred percent.

3. ADJOURNMENT

Motion: Councilman Liang moved to adjourn the meeting at 5:22 p.m. Councilman Jarriel seconded the motion, which passed unanimously.
