A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA WELCOMING THE ELECTION OF COMMISSIONER MELISSA MCKINLAY AS COUNTY COMMISSIONER FOR DISTRICT 6; EXPRESSING THE TOWN COUNCIL'S OPTIMISM FOR WORKING WITH COMMISSIONER MCKINLAY FOR THE BENEFIT OF THE RESIDENTS OF THE TOWN; PROVIDING FOR DISTRIBUTION OF THIS RESOLUTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.
