RESOLUTION NO. 2011-004

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, APPROVING AMENDMENTS TO THE INTERLOCAL AGREEMENT BETWEEN THE TOWN AND PALM BEACH COUNTY FOR BUILDING INSPECTION AND PERMITTING SERVICES AS A RESULT OF THE TERMINATION OF THE ZONING SERVICES AGREEMENT; AUTHORIZING THE APPROPRIATE TOWN OFFICIALS TO EXECUTE AN AMENDMENT TO THE BUILDING INSPECTION AND PERMITTING SERVICES AGREEMENT IN A FORM ACCEPTABLE TO THE TOWN MANAGER AND TOWN ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Loxahatchee Groves (“Town”) and Palm Beach County (“County”) agreed to terminate the agreement between the Town and County for Zoning Services, effective May 31, 2011; and,

WHEREAS, the Town and County are also parties to an agreement for Building Inspection and Permitting Services, which requires amendments in order to conform to the current duties of the Town and County as a result of the termination of the Zoning Services Agreement; and,

WHEREAS, under the Building Inspection and Permitting Services Agreement, changes to the document must be negotiated prior to May 15, 2011; and,

WHEREAS, the County has provided suggested language to amend the Building Inspection and Permitting Services Agreement, which the Town Manager and Town Attorney have reviewed and to which they do not object; and,

WHEREAS, the Town Council of the Town of Loxahatchee Groves finds that it is in the Town’s best interest to approve the changes to the Building Inspection and Permitting Services Agreement suggested by the County, and to authorize the proper Town officials to execute an

Amendment to the Building Inspection and Permitting Services Agreement in a form acceptable to the Town Manager and Town Attorney.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Town Council hereby approves the language suggested by the County for amending the Building Inspection and Permitting Services Agreement between the Town and the County.

Section 3. The proper Town officials are authorized to execute an Amendment to the Agreement between the Town and County for Building Inspection and Permitting Services in a form acceptable to the Town Manager and the Town Attorney.

Section 4. This Resolution shall be effective immediately upon adoption.
