Traffic Performance Standards (TPS) Review**

Dear Ms. Lai:

The Palm Beach County Traffic Division has reviewed the above referenced project Traffic Impact Statement, updated August 21, 2024, and supplemental changes and information provided to the Traffic Division, dated 11/14/2024, pursuant to the Traffic Performance Standards in Article 12 of the Palm Beach County (PBC) Unified Land Development Code (ULDC). The project is summarized as follows:

Municipality:	Loxahatchee Groves
Location:	East side of the C road, North of Southern Boulevard
PCN:	41-41-43-32-05-000-0010/-0020/-0030, 41-41-43-32-05-002-0000, 41-41-43-32-05-016-0000
Access:	Access driveway connection onto the proposed north terminus of C Road (C Road connects to Southern Boulevard to the south) <i>(As used in the study and is NOT necessarily an approval by the County through this TPS letter)</i>
Existing Uses:	Vacant (Unimproved)
Proposed Uses:	Recreational Vehicle Park = 285 Campsites
New Daily Trips:	943
New Peak Hour Trips:	60 (22/38) AM; 77 (50/27) PM
Build-out:	December 31, 2029

Based on the review, the Traffic Division has determined that the proposed development meets the Traffic Performance Standards in Article 12 of the Palm Beach County (PBC) Unified Land Development Code (ULDC).

Please note the receipt of a TPS approval letter does not constitute the review and issuance of a Palm Beach County Right-of-Way (R/W) Construction Permit nor does it eliminate any requirements that may be deemed as site related. For work within Palm Beach County R/W, a detailed review of the project will be provided upon submittal for a R/W permit application. The project is required to comply with all Palm Beach County standards and may include R/W dedication.

No building permits are to be issued by the City after the build-out date specified above. The County traffic concurrency approval is subject to the Project Aggregation Rules set forth in the Traffic Performance Standards Ordinance.

The approval letter shall be valid no longer than one year from date of issuance, unless an application for a Site Specific Development Order has been approved, an
