Town Hall is now open on a 5-day schedule:

Town Hall public hours are Monday-Friday: 8:30 AM - 4:30 PM
Public Works Department is open Mon.-Fri. 8:00 AM – 4:00 PM

- **It’s still Hurricane Season – Always be prepared with your home emergency plan!**
- Regular Town Council Meetings are usually 1st and 3rd Tuesdays from 7-10:30 pm, preceded by a “community discussion” (non-agenda) workshop prior from 6:00-6:55 pm
- **The First Town Public Budget Hearing is on September 8th (a Wednesday) and;**
- **The Second Public Budget Hearing is Sept. 21st (Tues.) to adopt the FY22 Budget.**

LG Public Meeting Attendance Protocols:

Covid-19 restrictions are limited in Florida, however when attending public meetings consider facemask use and social distancing within Town Hall for your personal protection. While many have been fully vaccinated, we cannot attest for everyone in the general public. Please take necessary personal precautions if you are sick or susceptible to infection (if you are sick with symptoms, please stay away). Public Comments can be presented in person, received by email or provided in writing to the Town Clerk’s Office until meeting time. Comments in writing are “received & filed” for the meeting record. Town Council meetings are live-streamed & close-captioned, with direct links to our YouTube channel from our website.
